



NU TAINMENT, LLC. Producer of Star International Model Competition.

The following rules and regulations apply to ALL contestants:

1. The contestant must be a naturally born female for the Miss Star International Model Competition and a naturally born male for the Mister Star International Model Competition, and is a citizen, resident or is attending school in the state / country for which she / he is competing. Residence or military establishment is acceptable (some exceptions can apply).
2. The contestant will be at least 18 years old in the year they would participate in the national and the international telecast. (Some exceptions can apply)
3. The contestant is and will continue to be a person of good moral character; she / he has not committed and will not commit any act inconsistent with the highest standards of public morals and convictions, or that she / he will reflect unfavorably on Star International Model organization, NT (Nu Tainment, LLC.) representatives, sponsors and or licensees.
4. The contestant possesses class and a good personality.
5. The contestant agrees to conduct themselves at all times in such a manner as is consistent with the highest moral and ethical standards. She / He further agrees to refrain from any act that, at the sole discretion of the Star International Model organization and NT (Nu Tainment, LLC.), is deemed detrimental to the interests of Star International Model organization, NT (Nu Tainment, LLC.), its organization; officers, directors, and representatives or sponsors.
6. The contestant hereby releases any claim in which she / he may have by virtue of her / his participation in this competition, or any use of her / his photograph, likeness, voice, or appearance in the connection with the exercise of any such rights, including advertising and promotional material relating to any such exploitation.

7. The contestant will NOT defame the Competition, whether it is oral, written or otherwise stated. Defamation of the Star International Model organization, NT (Nu Tainment, LLC.), shall result in automatic relinquishment of any title and prizes.
8. The contestant agrees to permit the Star International Model organization, NT (Nu Tainment, LLC.), sponsors, distributors, networks, stations, licensees, to use her / his name, picture, likeness, voice, signature, title, art illustration, biographical material, and/or the like of any advertising or publicity relation to the program and/or the Competition in perpetuity, without any compensation.
9. The contestant hereby represents that the contestant will continue to be a person of good moral character; that she / he has not committed and will not commit any act inconsistent with the highest standards of public morals and conventions, and that she / he will not reflect unfavorably on the Competition, its representatives, sponsors, and/or licensees.
10. Contestant will display good sportsmanship and honor the judges' decisions as final. Drinking alcohol and/or smoking is not allowed during the Competition! You are a role model for many people. If you are caught drinking or smoking during the competition, you will be immediately disqualified. All contestants are expected to conduct themselves in a professional manner while attending the Competition. We will not tolerate anyone making negative remarks about another contestant, the staff, Star International Model organization, NT (Nu Tainment, LLC.), the judges or the host hotel and venue.
11. Star International Model Organization and NT (Nu Tainment, LLC.) are not responsible for any items that are lost or stolen. Please take/mark all of your belongings. No one besides contestants and staff of the Competition and NT (Nu Tainment, LLC.) will be allowed in the dressing rooms or backstage at any time. This means no hair/make-up artists, family members, or guests. This rule will be strictly enforced. The Competition will provide a contestant's chaperone to assist with clothing changes.
12. Contestants must attend ALL Scheduled events leading up to the Competition. The Star International Model organization / NT (Nu Tainment, LLC.) has taken great steps in pre-planning this event. We are dedicated to providing you with a high-quality Competition and production. The scheduled events and rehearsals require advance planning. Attendance information will be made available to the judges. Contestants are required to arrive on time and participate in all scheduled activities.
13. All contestants agree to abide by all rules set forth by the Star International Model organization / NT (Nu Tainment, LLC.) and all related documents. If, for any reason, a contestant refuses to and/or fails to fulfill the duties and obligations associated with their participation, she / he will be disqualified at the sole discretion of Star International Model organization, NT (Nu Tainment, LLC.).
14. All contestants, who are minors, must have a legal guardian present for the duration of the Competition. Rehearsals will be open to parents/guardians (subject to approval).
15. No photography or video recording of the Competition or rehearsals is allowed. This includes cell phones. If anyone is caught taking pictures or recording during the Competition

or rehearsals, they will be asked to leave. In between activities associated with the Competition, contestants may take photo's and video's with their fellow contestants for personal use.

16. All fees paid to or donations to NT (Nu Tainment, LLC.) or Nu Tainment Charities are non-refundable.

17. Winners selected during the Competition will be required to make appearances throughout their reign. Star International Model organization and NT (Nu Tainment, LLC.) reserve the right to revoke a title if the titleholder continuously misses appearances. Other select models may be provided opportunities for making appearances.

18. During their reign, Competition winners are not allowed to compete in other modeling contests unless approved by the Star International Model organization / NT (Nu Tainment, LLC.) and are under exclusive contract with NT (Nu Tainment, LLC.) and the SIM (Star International Model) organization.

19. All legal matters regarding rules and regulations of this document will be settled in the state of Maryland (United States) and the contestant must be present to resolve any legal matters or have an official representative be present on their behalf.

20. Star International Model organization / NT (Nu Tainment, LLC.) reserve the right to alter or amend any provisions in this document, but is under no obligation to do so.

21. All eligibility issues are at the sole discretion of Star International Model organization / NT (Nu Tainment, LLC.)
